#### **Water Safety Tips**

From the Desk of County Supervisor Susan Peters

When enjoying our area's rivers to escape the heat please remember the following water safety tips.

- Learn to swim. The best thing anyone can do to stay safe in and around the water is to learn to swim. Always swim with another person; never swim alone.
- When boating, always wear a life jacket. California law requires any person under the age of 12 to wear a Coast Guard approved life jacket while in a motorboat or sailboat.
- County ordinance makes it unlawful to allow a child under the age of thirteen to enter either the American or Sacramento Rivers in the unincorporated area as well as other public waterways without wearing a life jacket. A similar ordinance is in effect for natural waterways within the City of Sacramento.
- "Loaner" life jackets are available at several access points along the American River including Ancil Hoffman Park, Howe Avenue, and Watt Avenue.
- Please do not mix alcohol and swimming. Alcohol impairs judgment, balance, and coordination, affects your swimming and diving skills, and reduces your body's ability to stay warm.
- Pay attention to local weather conditions and stop swimming at the first indication of bad weather.
- Lastly, know how to prevent, recognize, and respond to emergencies.

#### No Better Time to Look at Real Reform

One of the reasons I ran for State Assembly was because I did not think our budget reflected our priorities as a state and I thought it was time to advocate for a new way of doing the state's business. Politics as usual has stalled difficult choices and both parties have held onto their sacred ideologies without putting forward concrete and viable solutions to really solve our problems. We are facing years of borrowing to make ends meet, gimmicky budgets and over committing in the good years and failing to cut in the bad.

It's time we stopped nibbling around the edges and address real reform and the way we manage this state. It's time we examine our governing document, our constitution.

Over time, we have legislated at the ballot box and taken away the flexibility of all but 10 percent of our budget. The California Constitution is now 173 pages long compared to only 29 pages for the United States Constitution. It is the third longest constitution in the world.

We keep finding ourselves in the same dilemmas, yet we fail to address reform during the bad times, focusing instead only on the crisis at hand, and when good times return the motivation for reform is lost. However, I will not stop advocating for real reform that allows us to respond to economic crises and implement a vision for California.

#### **Legislative Update**

From the Desk of Assemblymember Dave Jones

I have introduced a number of bills this year to improve health care in California and to reform the insurance industry.

AB 1382 provides for 1 - 2 billion in matching funds, through a fee on hospitals, to draw down billions more federal funds. These funds, in turn, will help keep hospital doors open and will provide funding for children's health care.

A recent study demonstrated that women are often charged more than men for the identical individual health insurance policy. The price differences are not consistent, nor are they based on a woman's health costs – only since 2007 have women been charged up to 35% more. AB 119 would make it illegal to charge women more for an individual health insurance policy.

AB 23 requires health insurers to send out notices to all potentially eligible Californians informing of their right to keep their health insurance and of the 65% federal health insurance premium subsidy. AB 23 could help upwards of 100,000 unemployed Californians with their health insurance costs. AB 23 was signed into law on May 12, 2009 and became effective immediately.

AB 1179 requires insurers to let consumers know that they have the right to an independent auto body damage assessment before having auto body work done on a damaged car. Consumers often believe that they must accept the insurer's estimate of damage and settlement offer, only to discover that the true cost of repairs is thousands of dollars more than what the insurer paid them.

#### Why Thomas Jefferson Closed and Students Moved to Hubert Bancroft

No one wished to see Thomas Jefferson Elementary School closed. Why did the school board vote to do so? When we think of the school we consider its high student achievement, its staff dedication and outstanding parent support and participation. What are the facts? There is a financial crisis in our state that is greatly affecting public education. It began in 1978 when voters passed Proposition 13. That ballot measure took away school districts' authority to tax residents' to pay for the schools the community

wants. California has now fallen to number 50 in the ranking of per pupil funding in a ranking of the states. It requires about 500 students to keep a school running in the black. Jefferson's enrollment has dwindled to 206 students with little hope of increasing enrollment in the near future. Three other small schools were also closed with more to follow. When school funding was good the district could afford to subsidize small schools. After cutting \$125 million out of the budget since 2004 it can no longer afford to do so.

#### **Project MOVE Empowers Severely Disabled Children**

The Sacramento County Office of Education (SCOE) hosts several model sites for Project MOVE (Mobility Opportunities Via Education). Project MOVE is a research-based program that dramatically improves functional mobility skills and empowers severely disabled children to better direct their own lives. Project MOVE helps these children:

Acquire increased independence in sitting, standing, and walking,

Learn and gain more mobility, and

Experience better health and enhanced personal dignity.

Project MOVE also helps decrease the burden of care for families, and at the same time enable fuller participation and involvement in family life and in the community.

Developed in the 1980s by Linda Bidabe, a Kern County special education teacher, Project MOVE responds to a growing concern that students with severe disabilities are not learning the critical mobility skills that they need to benefit fully from educational programs. In fact, some – sadly – exit special education at age 22 with fewer skills than when they entered school at age 3 due to secondary complications from their motor impairments.

SCOE's Special Education Programs at four school sites have been designated as models for Project MOVE. SCOE is the first agency to host MOVE model sites in Northern California. With SCOE's leadership, implementation of



Project MOVE will gradually extend countywide.

#### **New Park for Small Dogs and Changes to Local Water Usage**

Granite Park now has a new feature for small dogs... their very own space. In response to community requests, small dogs now have their own designated space to run, play, and enjoy themselves. In addition to the small dog park, the larger dog park received new amenities. The large dog park now has new benches, drinking fountains, as well as a shade structure. Also, both the large and small park areas received turf renovations and a combined 88 additional trees. I hope you can come out and enjoy the new amenities and park improvements with your canine companions.

The City of Sacramento has passed a Water Conservation Ordinance that will provide customers rules regarding outside irrigation. The ODD-EVEN water run-off schedule will remain as is. Addresses ending in ODD number (1,3,5,7,9) may water on Tuesday, Thursday, and Saturday. Addresses ending in EVEN number (0,2,4,6,8) may water on Wednesday, Friday, and Sunday.


# New changes in water ordinance include:

- No watering between 10:00 a.m. and 6:00 p.m. on your watering day.
- No washing of sidewalks, parking areas or driveways except for immediate fire or sanitation hazards.
- No limits on amount of time during a watering day.
   Water run-off is prohibited.
- New landscaping may be watered every day for the 21 days after installation to allow for plants to root.
- Seasonal watering schedule limits watering to 1 day per week during wet season (after daylight saving time ends).

An initial violation will result in written notification to the property owner and tenant. Repeat violations will incur monetary fines up to \$500.

The Oki Park open space master plan is now complete. After a couple of months working with neighbors in the community, City Parks and Recreation Planning staff completed the design. Currently there is no funding to develop the park, however, the master plan will help the city compete for federal and state park funds when they become available. #### **More Levee Work Upcoming**

The U.S. Army Corps of Engineers (Corps) in cooperation with the Central Valley Flood Protection Board (CVFPB) and the Sacramento Area Flood Control Agency (SAFCA) is planning on constructing levee improvements near Glenbrook Park. The work will close a 307-foot gap in the slurry wall, and will be constructed later this summer. A public meeting on this project was held on June 24, 2009.

During the construction, the western portion of Glenbrook Park will be closed to public access. The public will be able to access the American River Parkway along the east side of the park.

Work on the levee is expected to occur during daylight work hours on a Monday to Saturday basis. Construction work is expected to begin in late August/early September 2009 and take about 6 to 8 weeks to complete. Following construction, disturbed areas will be restored to pre-project conditions. #### **Summer Deadliest Time Of Year For Teen Drivers**

According to National Highway Traffic Safety Administration, the 101 days between Memorial Day and Labor Day are the most deadly season of the year for teenagers. Teen deaths increase in May, continue to climb throughout June and reach their peak in July and August.

"Teens need to understand that freedom comes with responsibilities," said Matt Skryja. "Keep communicating with your teen driver about the choices they make behind the wheel. Texting while driving, distractions created by teen passengers, drinking, and driving while drowsy lead to thousands of fatal teen crashes each summer. Get these issues out in the open and make your expectations clear."

AAA recommends teens and their parents take time to understand the Graduated Drivers License (GDL) laws for California. AAA research finds that states with comprehensive GDL systems have shown a reduction in deaths among 16-year-old drivers by 38 percent. These systems allow new teen drivers to gain experience under less-risky conditions. AAA has been a long-time advocate for strong GDL laws in all 50 states.

Additionally, AAA Northern California is offering a new package of tools that can help keep teens safe on the roads this summer.

AAA Northern California's Teen Safe Driver package includes insurance, free associate AAA membership, and an optional coaching device installed in teen cars that alerts parents and their teens to unsafe driving patterns. #### From Jefferson School to Jefferson Park


The Neighborhood Association has asked that the management of Thomas Jefferson Elementary School be transferred to the City of Sacramento to be used exclusively as the Thomas Jefferson/College Greens Park until such time as the Sacramento City Unified School District is in a position to support a "comprehensive neighborhood school" on the site.

The College Greens community is significantly deficient in green space by City of Sacramento Parks and Recreation standards. The Jefferson area was set aside by Oliver Rousseau Homes to provide both school and park space for the College Greens residents. If the need for a school at the site no longer exists, then it is the position of the Association that the facility should be established as a community park for the benefit of the College Greens residents. On that premise, the Association has asked that the permanent structures remain as is and that the community be given access to them for local activities. The portable buildings should be removed and grass planted in their place to better serve the park needs of the community. The Association also asked that only landscaping with grass, trees and plants be permitted and, more specifically, that no community gardens be permitted on the grounds.
