

## Neighborhood Says "YES" to Surveillance Cameras

Over 300 residential families responded to our neighborhood survey regarding the installation of surveillance cameras, with license plate readers, at each of the entrances/exits about the neighborhood boundaries. To insure the integrity of the survey each card included in the findings was checked for residential status. Five cards without a name or valid area address were not included in the findings.

Over 90% of those responding supported use surveillance cameras to discourage area crime in the College Greens and Glenbrook neighborhoods. Most of those supporting the camera proposal, but not all, also supported a one time only \$25 property assessment to fund the project if necessary. However, a number of supporters of the camera project that did not want to participate in a property assessment said they would support a voluntary contribution with a number of individuals offering to contribute more than the proposed one time only \$25 assessment.

Most of those in opposition considered the use of cameras to be invasive while others expressed concern that the cameras would not address area foot crimes. While some supporters of the cameras did not support a property assessment most were supportive of recovery of our cell tower funds or establishing a 501(c)3 foundation in order to seek donations and grants to support the project.

In response to the findings of the survey the Association has initiated two actions: the application process for a non-profit foundation status via Assemblymember Kevin McCarty and Congresswoman Doris Matsui's offices and recovery of our cell tower revenues via Councilmember Eric Guerra's office. The Association is in the process of writing applications for grants in preparation for securing a 501(c)3 foundation. The Association will not consider a property assessment until all other options are exhausted. The CGNA thanks all those that participated in the survey.

#### **Increased Bicycle and Vehicle Patrols**



Now that the Region 6 East Patrol Area has been reduced to roughly half the previous size and the number of officers assigned to our area has doubled, the College Greens and Glenbrook neighborhoods are seeing more police presence on a regular basis. Five locations have been identified for regular patrols: The intersections at Wissemann Drive & Belmar Street, Chestnut Hill Drive at Citadel Way, Occidental Drive overpass at Bennington Way & Mediterranean Way and La Riviera Drive at Occidental Drive. Vehicle and bike owners are reminded that you must come to a complete stop at stop signs. The cost of a bicycle violation is the same as the cost of a motor vehicle violation. The added patrols at these areas are the result of recent citywide fatal accidents involving both vehicles and bicycles that have ignored road signs. In addition to bicycle riders and drivers, pedestrians are reminded to stop and look before crossing the streets. Cross streets at intersections and not in the middle of the block. Our patrol officers want you to know that these road signs and regulations are there for the protection of everyone and ask for your cooperation in keeping our neighborhood a safe place to drive, cycle, and walk.





#### Keep Cool Without Firing up your Summertime Energy Bill

As the weather heats up, SMUD customers turn to their air conditioners for relief. That's to be expected.

But even during the dog days of summer, there are ways to keep your home cool and save money on your energy bill. Try not to let your home heat up in the first place. Keep windows and drapes closed during the day.

SMUD offers a range of rebates and incentives on air conditioners, whole house fans, windows, cool roofs and other energy-efficient products. Visit www.smud.org to see what's available.

Meanwhile, there are a number of simple steps you can take immediately to reduce your cooling bill without sacrificing comfort. For instance:

- Set the thermostat at 78 degrees or higher. Every two degrees of cooling can save up to 10 percent on the air conditioning portion of your electricity bill.
- Change the filter on your air conditioner regularly. Dirty filters use between 5 and 10 percent more energy.
- Adjust ceiling fans to turn counter-clockwise in the summer.
- Turn off unnecessary lights.
- Give appliances a break in the late afternoon and early evening they make your home hotter.
- Set the timers on pool and spa pumps to run before 1 p.m. or after 9 p.m.
- Call 924-8733 for a free SMUD shade tree.

My family especially enjoys our whole house fan on evenings where it's cooler outside than it is inside. Opening up a few windows and turning on the whole house fan helps us beat the heat without using the air conditioner.

#### **Know What You're Breathing**

The Sacramento Metropolitan Air Quality Management District (AQMD) has launched an app, which gives daily air quality forecasts and air pollution conditions to residents in the Sacramento region. The new Sacramento Region Air Quality app can now be downloaded for free on mobile devices with iOS, Google Play, or Windows app stores.

"This app is our newest tool to help people know what they're breathing and provide a helpful health resource to our residents," said Larry Greene, AQMD Executive Director/ Air Pollution Control Officer. "This app gives residents in the Sacramento region easy access to knowledge that will help protect themselves and their loved ones from the harmful effects of ground-level ozone air pollution."

The app features the daily air quality forecast, plus current air pollution readings at monitoring sites in Sacramento County, Yolo County and portions of Placer, El Dorado and Solano counties. Users will also receive notifications when there is a Spare The Air or wildfire smoke alert in the region. Poor air quality affects everyone, but there is a higher risk for children, pregnant women, the elderly and those with respiratory problems, such as asthma or bronchitis.

The app's release coincides with the launch of the 21st Spare The Air season, an annual program by the air districts of the Sacramento region, which runs May through October. The AQMD issues Spare The Air alerts when ozone pollution is forecast to be high and asks you to reduce driving to reduce pollution. All of them deserve recognition because they took advantage of the opportunity to obtain top notch training and job skills that will improve their employment and life opportunities.

We also are also pleased to be expanding our partnership with NCCT. We soon will be extending the program to Placer County to train parolees and probationers that we now serve in that county.

If that isn't possible or the jacket is forgotten, all are welcome to borrow and return them at any of the sites including the Howe and Watt Avenues Accesses. #### Focused on 2015-16 Sacramento City Budget

My first few weeks in office have been focused on the City's Budget for Fiscal Year 2015-16. The good news is that the overall fiscal outlook for the City continues to improve which allowed the City to continue focusing on restoring core services and targeting important priorities.

This year, the budget included the allocation of 22.22 million in General Fund and Measure U resources for priority initiatives and investment in key areas including our police department – 15 new police officers, and funding for the City's gang prevention task force; our parks department – restorations in park maintenance services, park improvement projects; and increased staffing to combat illegal dumping and our fire department – increased fire department staff, and funds to renovate two fire stations. The budget also includes funds to modernize the 311 Call Center software to increase efficiency, and for increased staff for the Front Street Animal Shelter.

As a substantial part of these programs are made possible with Measure U funds, we remain incredibly appreciative to the voters of Sacramento for approving the measure. While the economic outlook is good, it's important to note that the City remains challenged to achieve long-term budget sustainability as expenditures continue to outpace revenue growth in future fiscal years.

#### Save Money with Energy Efficient Upgrades

As many of you know, in 2011 the City of Sacramento passed a resolution which brought the Property Assessed Clean Energy Program (PACE) to the City. I was a strong proponent of the PACE Program which provides homeowners here in Sacramento with energy efficiency, renewable energy, and water conservation improvements. PACE finances the entire cost of your improvement and the financing is repayable over the long term through your property tax bill.

One of my top legislative priorities this year, in the California State Assembly, is to improve on this program state wide. Through AB 450, we will allocate Cap & Trade dollars into the PACE Program. Cap & Trade is a state program that both regulates emissions and creates funding to reduce emissions. AB 450 will strengthen and expand the PACE Program and increase the number of homeowners who will have access. Increasing funding will both lower interest rates for the program and create local well-paying jobs. AB 450 will assist homeowners who want to become part of the solution to reduce greenhouse gases.

#### "Burglaries from Motor Vehicle" the Top Neighborhood Crime By Ron Alvarado

Our neighborhood experienced a total of 78 reported crimes over the last two months (April and May). Burglaries from motor vehicles once again topped the list with a total of 17 such crimes reported during the period. This crime consistently leads the number of crimes in our area. The day with the most reported overall crimes was on a Friday, with 18 crimes, and the day with the lowest number of crimes was a Monday, with 5 reported.

#### Capitol Update: Water Conservation and Drought Response By Rebekah Cearley

The issue of water conservation and drought response is on everyone's mind. The Governor, his Executive Branch, and the Legislature are all working to enact solutions that will address the current drought and lay the foundation for wiser, more sustainable long-term water use strategies statewide. The Governor proposed and the Legislature is considering funds in the 2015-16 state budget to address the drought, including \$2.2 billion for various State Water Board programs.

On April 1, 2015, Governor Brown issued Executive Order B-29-15, which established statewide water restrictions and conservation efforts, including a 25% statewide reduction in potable urban water use, based on a 2013 baseline. To reach this goal, the State Water Board adopted emergency regulations in May 2015, creating a unique conservation standard for each urban water supplier in the state to reduce potable water use between 8% and 36%, based on per capita use from summer 2014. Compliance will be based on progress since the 2013 baseline.

Each water supplier will decide how to reach their own reduction requirement, and how that will affect their customers. The City of Sacramento has been assigned a conservation standard of 28%; as of April, we had achieved a 19% reduction. While residents are currently permitted to water landscaping twice a week, the City recently approved a plan to more closely monitor water use and possibly reduce down to one watering day per week as soon as July if goals are not met. One thing that all residents should do is check irrigation systems and fixtures for leaks or other needed repairs, to limit unintended water use.

#### Working Hard for a Healthier Sacramento in Our State House

#### **Tips for a Safe Celebration with Fireworks**

Fireworks have been a part of holiday festivities for many years. While they certainly can add a thrill to any celebration, they can also be extremely dangerous and need to be handled safely and responsibly.

- Before lighting the fuse, make sure fireworks are legal in your area.
- Keep a first aid kit nearby; 9600 fireworks-related injuries occur in the U.S. each year.
- Wear eye and ear protection, cotton or denim clothing, long pants, and covered shoes.
- Ignite fireworks properly using a hard, flat, and level surface. If you must use grass or gravel, lay down a strong piece of plywood as a shooting surface. Never shoot them off in a metal or glass container.
- Ignite only in cleared areas. Never light anything if the wind is strong. Fireworks started 15,500 fires in 2010.
- Light one at a time. Read and follow label directions. Use a long-tipped lighter to keep your hands and face away from fuses. Quickly move back to a safe distance immediately after lighting the fuse.
- Keep spectators at least 75 feet away.
- Avoid alcohol and smoking. Do not use any substance that may impede your judgment or safety.
- Douse with water when done. Use a bucket or garden hose before discarding spent fireworks. Never pick up fireworks that have malfunctioned.
- Don't hold fireworks in your hands.
- Never let children play with fireworks. Even sparklers can be very dangerous because they can reach 1,800° Fahrenheit.

Don't let an accident or injury get in the way of your next celebration. Be smart and be safe.

#### **Real Estate Trends and Neighborhood Update**

Have you been thinking of selling your home? There is not enough inventory for buyers wanting to purchase a home today. Prices are rebounding. According to data from MetroList Services, Inc., the highest sale price in College Glen for 2015 (as of 05/31/15) is \$370,000 compared to \$340,000 for the same period last year with a couple of pending sales at a listed price of \$399,000.

Serious Buyers should be pre-approved and work with an experienced Realtor. Interest rates and home prices are expected to rise in the next year. If that holds true, buyers will pay a penalty if they pass up the opportunity today due to price appreciation, increasing interest rates, and increasing rents. Owning a home versus renting provides a significant increase in long-term wealth. It often seems like a stretch initially. I find that most people were nervous about making the payment when they bought their home 20, 30, or 40 years ago. According to data from MetroList Services, Inc. there were 44 homes sold in College Glen from Jan. 1, 2015-May 31, 2015 at a median price of \$299,950 and 7 condos at a median price of \$172,500. For comparison, there were 43 homes sold for the same period in 2014 at a median price of \$270,000 and 4 condos at a median price of \$144,000.
