

2020 Family Night Out Cancelled



The College-Glen Family Night Out has been cancelled due to safety concerns related to the COVID-19 pandemic. A very special "Thank you!" to Councilmember Eric Guerra for working passionately and creatively with us to reimagine the CGNA Family Night Out event during this time of social distancing. However, after a comprehensive review of the risks associated with hosting the event, it was clear we could not gather safely and withdrew our event permit request.

The goal of our Family Night Out event has always been to enhance the relationship between neighbors and the members of our public safety community. We have consistently had participation from the Sacramento Fire Department, Sacramento County Probation, SWAT, and the Sacramento Police Department including patrol cars and motorcycles, mounted police, and K9 patrol. This event gave neighbors an opportunity not only to socialize with their public safety officers but to climb into the seat of a fire truck or squad car, balance on a motorcycle, learn about the role of the mounted patrol, and see the friendly side of many police dogs. Social interaction was a key element; neighbors laughing with each other; the CGNA providing hotdogs, drinks, and cake; our CGNA business sponsors sharing information and treats; volunteers painting faces and crafting balloon animals for kids of all ages; Raley's outfitting a cookie decorating station three tables long; the Crocker Art Museum engaging visitors in magical crafts; volunteers from Albert Einstein Middle School and Rosemont High School helping set-up in the morning and handing out glow sticks in the afternoon, and local elected representatives bending ears with residents and helping pass out cake.

All of this set to a foot tapping sound track that grew into a patriotic celebration featuring the presentation of colors by the neighborhood Girl and Boy Scout Troops, a live rendition of the National Anthem performed by Ben Billeci, and a pyrotechnic celebration provided by TNT/ Red Devil Fireworks.

We considered all the personal interaction and activities visitors have come to expect and enjoy and realized that with the current coronavirus public health concern, it just is not safe and responsible for CGNA to put on the Family Night Out this year. We look forward to bringing this event back to Olivet and Hastings Courts in the future!

Unfortunately, gatherings with more than 10 guests within the County of Sacramento continue to be prohibited by the Sacramento County Health Department. Our National Family Night Out, like most other fireworks shows, have been suspended for 2020. However, the TNT Red Devil stands will be open from June 28th thru July 4th. TNT wants everyone to enjoy their fireworks and to be safe.



The toddler program meets on Friday mornings (8:30am to 11:15am) and is open for 2-year old's with a monthly tuition of \$80. For registration and more information please call Ms. Paula at 916-247-3335. A \$50 deposit is required to place a hold on a spot until September when school begins. All classes have a parent participation component. Each parent/grandparent works in the classroom one day a week in the preschool classes. During the Friday toddler program a parent/grandparent must be with the child at all times.

Supporting Students and Families with Enrichment Materials

As we begin the new school year, many families in our community will need additional educational resources to support their children at home. The Sacramento County Office of Education (SCOE) is committed to helping our families and our young people by making sure students have positive activities, and that parents have informational materials to help them better work with their children.

SCOE maintains an educational video catalog, designed to provide students, families, and school districts with supplemental enrichment materials to support learning as we continue to deal with the impact of COVID-19.

We have collaborated with the Sacramento Educational Cable Consortium (SECC) to support at-home learning by producing video lessons and supplemental materials for the SCOE website (www.scoe.net), the SECC website (www.secctv.org), and SECC's educational cable channels on Comcast, Consolidated, and U-Verse. Our curriculum experts deliver the video lessons and supplemental materials, which cover a wide range of topics from virtual field trips to our outdoor science education program at Sly Park to managing anxiety and emotional well-being. We continue adding content regularly.

These supplemental materials are valuable because they give families an opportunity to approach education topics in new ways, possibly different from what students might already have been learning in the classroom. They also give parents the opportunity to address topics that might not have been presented in the classroom. We hope some of these activities will fill in the gaps and put parents in a position to enhance the education of their children.

"Food for Thought" has Double Meaning

Keeping kids well-nourished continues to be a priority for Sacramento City Unified School District (SCUSD). According to the Nutrition Services Department, the District is nearing its "two millionth meal served" since school closures began on March 16 due to the coronavirus pandemic. Thirty-one school sites have been giving away free breakfasts and lunches for children age 18 and under, including Bancroft Elementary. Since we started to serve breakfast and lunches, Bancroft Nutrition staff has prepared and served an average of 130 meals per day.

Beginning Monday, June 15, the following school sites will continue to offer one breakfast/lunch per child/per day (while daily supplies last), from 8:00-10:30 a.m., Monday-Thursday:

Elementary – Elder Creek, Ethel I. Baker, James Marshall, John Still, Matsuyama, Oak Ridge, Pacific and Parkway.

Middle and High Schools – Health Professions, Rosa Parks, Rosemont, and West Campus.

Whether students are participating in distance learning or are in the regular classroom, staying well-fed and healthy is critical to their success. There are no forms to complete to receive these meals; participants only need to be 18 or younger. Please check with the site closest to you for any procedures they may have in place. The District hopes everyone has a healthy, safe summer.





Our Path for Reopening Sac City Unified Schools

On June 11 Sacramento City Unified wrapped up a school year that was like no other. Mid-semester we shifted to distance learning while our community complied with shelter in place orders to slow the spread of COVID-19. We mobilized quickly to continue meeting our students' academic, social and emotional needs: distributing millions of meals, tens of thousands of computers, and internet access for families. We celebrated the class of 2020 with virtual graduation ceremonies.

We remain concerned about learning loss – and ask returning students to keep district-issued computers to access district resources and support. We will also continue to provide meals for students this summer at 13 school sites.

We look forward to our students return on September 3 and are planning now for reopening. While we face some uncertainty, we know it will be different from when our schools abruptly closed. We will use state and county guidelines released in the last few weeks.

We're designing our district's plan using these guidelines, as well as research, surveys and community feedback. We will continually engage with stakeholders for input before and after drafting our final plan. As circumstances evolve, we will remain nimble and adjust

as needed to best protect the safety, and academic, social and emotional needs of our students and community. When school resumes, our schools must also be prepared to recognize and address the stress caused by weeks in isolation, and collective trauma. Our schools must not only be safe, but be emotionally safe spaces for everyone.

We have four week class sessions ending July 2nd, as well as classes that start later in the summer (July 6th-July 31st). Los Rios Community College District is also offering six and eight week classes, with various start dates throughout the summer. This offers students the flexibility to work around jobs or vacations, as well as to accommodate students who may realize later on that they want to take on a class.

All summer learning is happening online! Be sure to register ASAP for summer, as many classes are getting full or have waitlists. Fall enrollment began a week ago, so if you know you will be attending community college, make sure to head to our website www.losrios.edu to register.

With the cost of college going up and many colleges moving to remote operations, it is a great time to pursue your academic dreams at your local community college. California Community Colleges are an affordable way to earn a degree or certificate, and to save money before transferring to a four-year university. The vast majority of our students qualify for free tuition through the Los Rios Promise, which combines local and state money to eliminate financial barriers for students. Many students qualify for additional financial support as well, such as federal financial aid and scholarships. Now is a great time to check out the Los Rios Community College District!

Distance Learning and Graduation

Los Rios Community College was one of the first schools to suspend face-to-face classes, beginning March 13th. The district swiftly moved to 100% remote operations including moving all classes and student services online. This was a historic decision for us and one that wasn't taken lightly. Across the district, we made sure we were continuing the most critical services that our students need. Our colleges used all available resources to provide computers for students who have limited access to technology. We also continued to provide important on-campus food distribution opportunities. Lastly, we refunded students for parking permits and health center fees.

Unfortunately, we were not able to have our in-person commencement (graduation) ceremonies. In lieu of this, the colleges mailed each and every graduating student an official commencement program, a letter from the college president, and an official Class of 2020 tassel. Additionally, all graduates will be invited to participate during the Spring 2021 in-person commencement ceremony.

We also created a number of opportunities for graduates to tell their personal stories and share their experiences with their classmates and loved ones on the college's official social media channels. The colleges put together a video for their students as well. While we are sad we could not celebrate in person with everyone, we want to congratulate our students on their hard work and accomplishments, even during this uncertain time. Way to go, grads!

on the SCOE guidance document that was developed in collaboration with all 13 school districts. SCUSD also announced the creation of an on line calming room packed full of resources and tools to help with anxiety, uncertainty like exercise, mediation, arts and music, yoga, games, funny videos and resources.

Hornet Commons Student Housing Project Update

A year ago, Sacramento State and the University's partners broke ground on the Hornet Commons student-housing project. The \$164 million apartment complex for upper-level students is being be built on the former site of the Dan McAuliffe Memorial Ballparks, on the southeast side of campus. Despite the COVID-19 pandemic, the project is still on schedule to open before the start of the Fall 2021 semester.

When completed, Hornet Commons will house more than 1,100 students. Students will live in 284 apartments, across six four-story buildings surrounding a swimming pool. The project will also include a common building, which will contain a cafe, fitness center, and community room. Sacramento State juniors, seniors, and graduate students can choose from 212 four-bedroom and 60 two-bedroom units (all with four beds per unit), and 12 one-bed studio apartments.

As part of the project, the McAuliffe baseball complex has been relocated to city-owned land at Army Depot Park.

Use a Life Vest

Visiting the American River Parkway is a traditional way to cool off during the summer but remember Life Looks Good on You and so does a life vest -- Drowning doesn't.

Putting a life vest on before going into the river is the smart and safe thing to do. And it's the law for children under 13 to wear a life vest because kids don't float.

If you don't have one, there are several life vest borrowing stations for kids on the American River Parkway including both the Howe Avenue and Watt Avenue river access points. For more information, please visit regionalparks. saccounty.net.

Public Health Reminder

As more people engage in activities formerly restricted due to COVID-19, Sacramento County's Public Health Office reminds everyone the best defense against the virus continues to be:

- •Staying at home and physical distancing
- •Washing hands frequently
- •Avoiding touching eyes, nose and mouth with unwashed hands
- •Avoiding being around people with COVID-19 symptoms

Using cloth face coverings whenever social distancing cannot be maintained indoors or outdoors is also advisable. These do not have to be medical grade respirators and surgical masks. A simple cloth face covering should cover the nose, mouth and chin, and be made of soft or permeable material, without holes or one-way valve that allows respiratory droplet release.

2020 Sac State Graduates Hit their Finish Line Despite Hardships By Dixie Reid

Graduation for Sacramento State's Class of 2020 was unlike anything in the University's 73-year history. Students who had completed their degrees and returned to carry on the tradition of taking cap-and-gown photos found a nearly empty campus, because of the COVID-19 pandemic that so changed their final semester.

Along with disrupting their education, the pandemic upended students' lives, leaving many feeling overwhelmed, confused, anxious, and disappointed that their time at Sac State did not end as they had dreamed.

Commencement ceremonies at Golden 1 Center for 9,778 graduating seniors — the largest class in Sac State's history — were postponed until May 2021 because of COVID-19. The University made the decision in mid-March to move to online learning, leaving this year's graduates little time to say goodbye in person to their professors, campus administrators and staff, and friends.

Sac State honored the 2020 graduates with a virtual celebration June 6 to commemorate their accomplishments until everyone can reunite at Golden 1 Center next year. University President Robert S. Nelsen, understanding those feelings, praised Sac State's graduates for their toughness of character.

"It's the most resilient class I've ever seen in my entire life. Everything was thrown at them, and they didn't let it stop them. Instead, they persevered and succeeded," Nelsen said. "They came here because they wanted to be on campus, to be with the faculty and to have a face-to-face experience, and they wanted an education. They didn't let COVID-19 stop them from getting that education."

Residential Burglaries...Summer Heat and Delta Breezes

With a taste of summer's simmering heat hitting us in May, we should all be reminded that with the summer, open windows and unlocked patio doors, comes an easy invite to a residential burglar. Let's not make it easy to be targets for burglaries as summer comes upon us. In those nice evenings when the cooling Delta breezes come through and we open our houses to let the fresh air in, remember to close and lock up before bedtime.

Let's also remember to roll up the windows and lock the doors of vehicles left outside of our garages. Vehicle theft and burglaries from cars parked in driveways and on the street in our neighborhoods are always amongst the highest reported crimes.

CGNA/Bancroft Dumpster Now Accepting Only Cardboard, Cans, Plastic Bottles

Recycling of loose paper has declined in value and when mixed with cardboard can dilute the value of the cardboard by as much as 25%. It is not so much the loose paper, but the other items that tend to come in with loose paper such as soiled drink cups, food wrappers, and other unacceptable items for the dumpster. By moving to collecting only cardboard, CRV aluminum cans, and CRV plastic bottles we can increase the value of this recycling effort.



Staying at Home Prompts Spring Cleaning

The stay-at-Home mandate has resulted in extra time to do all of those household projects that had been shelved for another day. Residents have been cleaning their closets, garages, and yards. This has resulted in collections of items that needed to be disposed of. The City's loose-in-the street pickup for green waste has ended and will not return until November. However, residents may still have a green waste pick-up under the Household Junk Pickup program. The City of Sacramento solid waste/recycling customers have two free household junk pickups a year per household during the non-leaf season or until November 1, 2020. In addition, customers may request one free dump coupon for self-haul of debris to the Sacramento Recycling and Transfer Station per calendar year. Acceptable bulky items include yard waste, furniture, mattresses, carpet, toys, and four un-mounted tires. The City will collect up to 5 cubic yards of material (4'x4'x9') per appointment. An extra charge may apply if your load is in excess of 5 cubic yards. Beware



that piles placed out more than 24 hours before an appointment or without an appointment will be considered illegal dumping and fines may be issued.

Appliances, TV's, computers, and other e-waste are not acceptable within the Household Junk program. For these items, you may request two curbside pick-ups.

A full list of services available and guidelines for the various programs can be found at www.sacrecycle.org. To request an appointment, customers may call 311, make an online request at www.sac311.org, or use the Sac 311 App with your iPhone or Android. The dump coupons and the appliance/e-waste programs operate year-round.
