

Contribute and Make A Difference!

Thanks to all our 2020 supporters. It was a different kind of year, but our community continued to support the Neighborhood. A special thanks to the 588 College-Glen families that contributed to the Association/Foundation this year. Your financial contributions provide the resources needed to represent the neighborhood. Unlike a Homeowners Association we do not have mandatory fees; we operate totally with voluntary support.

We are a group of neighbors working with local leaders to encourage citizen involvement toward the resolution of problems existing within our defined boundaries and to identify and try to resolve problems in the surrounding vicinity that could have an impact on our area. This year, in spite of the pandemic, we were able work with council member Guerra to enact a special ordinance prohibiting permits for massage parlors, checking centers, tobacco shops, and cannabis dispensaries along Folsom Boulevard between 65th Avenue and Watt Avenue.

The effectiveness of the Association's representation is directly related to the number of volunteers and financial donations that our residents make to the Association. Contributions, in addition to reflecting community support for our efforts, provide us with the financial means to represent our neighborhood. Our quarterly newsletter is our primary source of communication with area residents and it is our greatest expense. The printing and related costs for our newsletter is approximately \$1,800 per issue. The price varies with the number of inserts and number of pages in the edition. We also mail copies to some of our sponsors and new contributors, all adding to the cost of the 3,000 copies distributed.

All residents residing within the boundaries of the Association receive a printed newsletter four times a year delivered by neighborhood volunteers. An electronic copy of each newsletter is also available on the CGNA web site. We currently have 76 individuals from 43 families assisting with the news deliveries. Routes range in size from a low of 45 to a high of 112 homes per route. Without the voluntary assistance of our delivery families, the cost of mailing the newsletter would be prohibitive. We hope that you read and benefit from our newsletters.

While we were forced last year to cancel our social events, we are looking forward to their return. In the meantime, we have purchased a Zoom account and are continuing to communicate via Zoom. For your use and convenience, we have enclosed a 2021 contribution form and a return envelope. Please note the 2021 contribution form asks if you would like to be given electronic notice of special events and area crime alerts. To effectively provide this service, we will need both your e-mail address and a working phone number. We do not share your contact information with others and limit our communication to that necessary to keep you informed of relevant events within the community. We thank you for your continued support.

Pick-up day for Garbage, Recycling and Yard Waste is Friday

Weekly garbage and yard waste containers will now be collected on Fridays with recycling collected on alternating Fridays. The City's loose-in-the street pickup has ended and the Household Junk Pickup has resumed.

Each City of Sacramento solid waste/recycling customer may again have two free Household Junk Pickups a year per household during the non-leaf season. In addition, customers may request one free dump coupon for self-haul of debris to the Sacramento Recycling and Transfer Station for the Household Junk Pickup program per calendar year. Acceptable bulky items include yard waste, furniture, mattresses, carpet, toys, and four unmounted tires. The city will collect up to 5 cubic yards of material (4'x4'x9') per appointment. An extra charge may apply if your load is in excess of 5 cubic yards. However, beware piles placed out more than 24 hours before an appointment or without an appointment will be considered illegal dumping and fines may be issued. Appliances, TV's, computers, and other e-waste are not acceptable within the Household Junk program. However, you may request two curbside pick-ups for appliances, TV's, computers, and other e-waste during this household junk period. To request an appointment, customers may call 311, make an online request at www.sac311.org, or use the Sac 311 app with your iPhone or Android. The dump coupons and the appliance/e-waste programs operate year-round.

SCOE Launches Scholarship Program for County Office Students

The Sacramento County Office of Education (SCOE) is announcing the establishment of the SCOE Resiliency Scholarship by the Board of Education. The program will support graduating students who have attended SCOE Court and Community Schools, Leo Palmiter Jr./Sr. High School, and the Senior Extension Program.

Many students SCOE serves demonstrate tenacity and perseverance in overcoming adverse challenges to complete their education and advance their futures. The SCOE Resiliency Scholarship rewards SCOE students who have demonstrated determination and resilience in overcoming obstacles and to help support them in pursuing post-secondary education or vocational training and development.

Scholarships will be awarded to deserving students in amounts of \$500-\$1,000,

and recipients will be matched with mentors to support them as they navigate their post-secondary education and/or vocational training.

Graduating seniors who have attended SCOE schools during their educational journey are eligible to apply.

Community, City Step up to Feed Sacramento State Students Over Break By Dixie Reid

Thanks to a program created by Sacramento Mayor Darrell Steinberg's office, and supported by Councilmen Eric Guerra and Jeff Harris, Sacramento State students in need have received regular deliveries of restaurant meals and groceries during the Winter campus closure when students typically do not have a paid meal plan. The program, created for the University, continues to give students two meals a day during the week and groceries each weekend through Friday, January 22.

"Mayor Steinberg and the City have come through for Sacramento State once again," said University President Robert S. Nelsen. "In fact, all of Sacramento has come through for Sacramento State."

Even before the pandemic hit, nearly half of Sacramento State's students had experienced food insecurity. Matters worsened as students, and often their family members, lost their jobs and struggled to get enough to eat. With campus dining traditionally not available during winter break, students likely would have ordered restaurant delivery through services such as Door Dash, which can get expensive.

Delivering food to campus were staff from the Mayor's Office and the offices of Vice Mayor Jeff Harris, Councilmember



Rick Jennings, and Congresswoman Doris Matsui. Representatives from the Sacramento City Unified School District's Nutrition Services Department also have volunteered. Local restaurants and businesses supporting the effort included Alaro, Ambrosia Catering, Canon, Mulvaney's B&L, Urban Roots, and Raley's.

SCUSD Working Toward Safe In-Person Student Learning

Sacramento City USD continues to offer a Distance Learning-only option this school year. Despite the hard work of our teachers and school staff to support our students, it's clear that students learn best in an in-person instructional setting.

With this goal in mind, the District continues to update the Return to Health plan based on local, state, and federal guidance to meet the necessary health and safety conditions for in-person instruction. The District also continues to work with labor partners on working conditions.

Recently both Federal and State governments have prioritized reopening schools for in-person instruction to address student learning loss. Schools will receive federal and state resources—potentially in the millions for Sacramento City USD— to fund COVID-19 related costs—vaccines, personal protective equipment, and extended learning opportunities.

Meanwhile, the District has partnered with the City of Sacramento and community-based organizations, to operate Learning Hubs at limited school sites prioritizing students with the greatest needs—foster students, students experiencing homelessness, students receiving special education services, English Learners, and students of essential workers. These opportunities have proven to have had a positive impact on attendance, student engagement, and academic and social-emotional well-being.

I look forward to the day when our students can return to safe in-person learning environment— both as a School Board Member and as a parent of two primary school students in the District.



Big Yellow Dumpster Needs Your Help

The Big Yellow Dumpster project is a great idea! All revenue generated from recyclables deposited in the dumpster go straight to Bancroft Elementary School. However, the dumpster is losing its value because community members are putting in items in that are not accepted in this dumpster. Our Yellow Dumpster can only accept clean cardboard and other clean paper goods, and clean CRV plastic and CRV aluminum. If inappropriate items are deposited in the dumpster the value of the contents is reduced significantly. Clean cardboard has a value. Soiled paper goods and cardboard have no value and can contaminate the entire dumpster. We cannot accept metal cans, pill bottles, paper and plastic milk containers, and soap and other cleaning product containers. Waste Management, the collector of the City's waste products, has a process for recycling these and other types of recyclable materials. Please use the City's recycling bins for these recycling products.

The dumpster is in the Bancroft parking lot to provide the community a place to deposit their CRV recyclables and large cardboard items. The project was started to reduce the value of the waste products in your home recycling bin and as a way of discouraging scavengers from going through your residential recycling bins, all while helping our neighborhood elementary school. Please limit your deposits in the yellow



dumpster to clean paper goods and CRV plastic and aluminum. Please remove all styrofoam and metal from your paper products before placing them in the yellow dumpster.

Thank you for your assistance with this program. Thank you for all of your CRV containers and clean cardboard.

To Customers and Neighborhoods During Pandemic: SMUD is Here to Help

SMUD has gone to great lengths to ensure the reliability of our power grid during the COVID-19 crisis. Keeping the lights on safely is our top priority, and with more than half of our employees working remotely since last March, we've continued providing the reliable service our customers expect.

At the same time, we recognize that many of our customers are struggling to pay their bills during these difficult times. We've extended the moratorium on customer disconnects for non-payment through at least April 2021. Customers who are behind on payment will still owe SMUD for service, but they won't need to worry about losing power or having to pay late fees.

We've also continued our support of local nonprofits and community organizations during the pandemic. For example, we're providing micro loans of up to \$10,000 through our Sustainable Communities initiative for non-profits affected by the coronavirus.

As the Sacramento region re-emerge from the current crisis, it's important to pool our resources and help everyone get back on their feet. For SMUD, these efforts start but don't end with making sure the lights stay on.

District 6 Update/Homeless Master Plan

From the Desk of Councilman Eric Guerra

I hope you all had a safe and joyful holiday season in the company of family and loved ones! There is no question that 2020 was a challenging year for us all. The pandemic has challenged us all and gave us an opportunity to reflect on important things that we may have been taking for granted. This past year has also shown how we all can work better together in the toughest of times. As we enter into the New Year, I wish you a year filled with the promises of a brighter tomorrow and a chance for all of us to start a new, more forward-looking chapter in our lives.

The New Year offers an opportunity to reassess and look at some of our most pressing issues with a new focus. One of the most evident challenges is the issue of homelessness. During the first council session of 2021, my colleges and I brought forward a discussion to start developing a City-wide Homeless Master Plan to address the urgent need and to increase sheltering and wrap-around services for neighbors experiencing homelessness.

While the City of Sacramento has made significant investments and efforts to address homelessness, the COVID-19 pandemic has brought an unanticipated and surging increase in the numbers of people experiencing homelessness due to the economic impacts on many of our residents. Limited resources to house and support our residents experiencing homelessness require all of us to make a collective effort to meet those needs in collaboration with the community, businesses, religious organizations, non-profit organizations, and others.

The Master Plan will include an equity lens across all neighborhoods and a process to provide opportunities for the community to engage and provide input. Our goal is to develop a plan that will reflect City-wide needs, tailored to the resources available in our council district.

In the coming weeks our office will be organizing meetings with representatives from neighborhood associations, local businesses, and service providers to assist in developing a strategy and identifying resources to meet the short, medium and long-term needs of residents experiencing homelessness in District Six. I am encouraged to have already received many suggestion from neighbors on how we can collectively work together to find not only sustainable solutions but meet the immediate needs we see on our streets today.

The City Council will hold additional workshops where the public will have opportunities to learn and provide input. The Council will take a single vote on the Comprehensive Master Plan, scheduled for June 2021, identifying sites and resources in each of the council districts.

Real Estate Thrived in 2020

Happy New Year! 2020 was an unprecedented year. We worked from home and students were home schooled. We cancelled travel plans, little league games, school and charity events, sporting events, and holiday gatherings. Some businesses thrived while others struggled.

Spring Update

As we approach Spring 2021, you will see more on-levee activity from our flood protection crews. Three main activities will be noticeable this time of year. One is mowing the grasses that begin to grow tall and obscure our observations of the solid structure of the levee surfaces. We are now using our new robotic remote-controlled mower that is now able to access the steepest portions of the levee slopes and makes it physically safer for our operators.

Second, you will regularly see our trucks on the levee crown driving slowly looking for any potential problems, such as cracks, slumps, erosion and fallen trees, especially during the rainy season that begins about this time of year.

Third, you will see us completing repairs to the levees themselves. Typical work includes adding gravel to the levee crown, removing dead and dying trees, filling dangerous rodent tunnels intruding in to the levee, and resurfacing the levee slopes where erosion during the winter has occurred.

If you see our crew on the levee, feel free to wave "Hello." They would appreciate your recognition.






CGNA's River Access Garden Update

2020 Zoom Annual Meeting/Candidates Forum Well Attended

The CGNA and Foundation's Annual Meeting and Candidate Forum took on a different look this year but was still well attended. What had become our traditional Fire Station 60 social was not acceptable under the current social distancing guidelines. The event was held over Zoom this year.

Our Media Chief Carl Kelley coordinated the technical needs and laid out a floor plan for social distancing. Each of the 23 invited speakers were offered to join either in person while practicing social distancing or via Zoom. We had 103 guests join us via Zoom - a great first by itself. We hope to return to Station 60 for our next CGNA Annual Meeting but will likely continue to offer the option for Zoom attendance.

Our meeting started with the election and introduction of officers and directors followed by the 2020 financial reports. Included in the review of the year's activities was a summary of the special community meetings related to proposed ban on massage parlors, cannabis dispensaries, smoke shops, and check cashing shops along Folsom Boulevard. Following the reports guests heard from members of the Sacramento Police and Fire Departments; Sacramento County: Probation, Office of Education and Flood Control Board; Los Rios Community College District; SMUD; California Montessori, Christo Rey, Bancroft, Einstein, and Rosemont Schools; SCUSD Superintendent Jorge Aguilar, Councilmember Eric Guerra, and Assemblymember Kevin McCarty. Next, candidates for Sacramento County Board of Supervisors District 3, California Assembly District 7, SCUSD Area 3, Los Rios Trustee, Area 7, U.S. House Representative District 6, Proposition 15, and Measure A.















Holiday Crimes a Big Portion of 2020 Crime

Of the 325 crimes reported in our neighborhoods during 2020, 42% of them were committed during the long holiday season, beginning just before Thanksgiving, and ending a few days after New Years Day. Some 136 crimes were reported from November 20, 2020 through January 4, 2021 while 189 crimes in the reported categories were reported from January 1, 2020 through December 31, 2020. The most prolific crime reported during the 2020 calendar year was theft, and theft ranked number one for the holiday period as well. Burglars continue to prey on "removing" articles from our cars, and seem to take aim at stealing our cars as well.
