# SCOE Supporting Local Students with Special Summer Program

When students return to in-person instruction when the new school year starts, the focus on academic instruction will be intense. At the same time, both students and staff have experienced unprecedented levels of disruption and stress that will impact their ability to focus on learning.

To enhance learning for students preparing for the upcoming year, we at the Sacramento County Office of Education (SCOE) are proud to be partnering with the Sacramento City Unified School District, San Juan Unified, and Twin Rivers Unified, plus several community-based and non-profit organizations, to provide students with opportunities to re-engage with the excitement of learning.

Our **FREE** Summer Education Innovation Centers – at Rosa Parks School in Sac City Unified, F.C. Joyce School in Twin Rivers, and Thomas Edison Language Institute in San Juan Unified - are operating through July 30. The centers offer a variety of integrated hands-on experiences such as arts, social and emotional learning activities, outdoor education, physical activities, and science experiments. The participating third through eight graders receive breakfast and lunch at no cost.

One of the most gratifying parts of the program is the fact that all participating students have peer mentors to work with them and support them. And those mentors are learning skills and gaining valuable experience that they could cite on a resume or job application.

# Pre-School & Toddler Program Anticipated In-person Instruction

For the past 23 years Ms. Paula has been working with parents, helping their pre-school child with socialization, balance, and hands on coordination skills. Ms. Paula, the parents, and the students are ready to return to in class instruction. There will be some changes and mandates to ensure the safety of the students, parents, and staff but the plan is to return to the classroom and play yard for Fall 2021 and beyond.

Holding deposits continue to be accepted during the summer for the Fall 2021 pre-school and toddler programs. You may register with Ms. Paula or at the McClaskey Adult Center. There are limited openings in all three classes. The 4-day morning preschool meets Monday through Thursday from 8:30am to 11:15am. The afternoon class meets from 12:00pm to 2:45pm, Monday through Friday. The Friday morning toddler class meets from 8:30am to 11:15am. A \$50 deposit is required to place a hold on a spot until September when school begins.

# Sac State Prepares to Safely Welcome the Hornet Family Back to Campus

Sacramento State will be alive with more activity than it has experienced since the March 2020 COVID-19 shutdown, with faculty, staff, and thousands of students returning to campus this fall. That optimistic outlook is grounded in the reality of near-constant change in local, state, and federal safety guidelines that keep some details still undetermined. The message to the campus community, however, is clear: Be ready to come back.

The University is embracing the theme "Hornet Family. Together Again," and Sac State leaders are working to ensure students will have a safe and successful fall semester when instruction begins Monday, August 30. Students will find classrooms upgraded with "smart" elements. Other improvements include more Wi-Fi availability and new shaded outdoor venues for studying and safely gathering with friends. Air conditioning system (HVAC) filters have been upgraded, too.

The return also will effect on-campus living, with about 2,000 students expected to settle into the North Village residence halls and up to 1,100 students at Hornet Commons, a new apartment-style complex on the south end of campus. Residence hall occupancy had been limited significantly during the



Spring 2020, Fall 2020 and Spring 2021 semesters. Other campus amenities, including the University Union, University Library, The WELL, athletic events, and performing arts performances are planning for a full re-opening for the fall semester.

COVID health and safety measures will remain in place until the CSU and Sac State can align with the changing guidelines determined by various government agencies. New government guidelines are expected to be rolled out this summer, and the University plans to have revised safety protocols in place soon after.

## Sacramento's New Building Electrification Ordinance Aligns with SMUD's Zero Carbon Plan

The Sacramento City Council recently passed a building electrification ordinance establishing phased requirements for new construction to be all-electric. The ordinance requires all new residential and commercial buildings under three stories to be all-electric beginning in 2023. New buildings four stories or higher must be all-electric by 2026.

The city's new ordinance aligns with the goals and direction of SMUD's 2030 Zero Carbon Plan. As SMUD's reliance on carbonbased fuels decreases every year, the electrification of California's two largest energy sectors - buildings and vehicles - will reduce greenhouse gas emissions and improve local air quality.

It's important to note that the city's electrification ordinance includes exemptions for restaurant cooking through at least 2025 and additional waivers where suitable solutions are not available.

The electrification of buildings has been a part of SMUD's decarbonization effort since we launched an all-electric incentive program in 2018. Approximately 60 area builders and developers are participating in our Smart Homes program, with nearly 500 projects completed and another 2,400 all-electric units in the pipeline. Several affordable housing projects are included in the program.

SMUD's electric grid has the capacity to serve the growth in all-electric buildings, Reliability is a core SMUD value and will always be given top priority. We have the resources and capital investment plans in place to ensure that all customer energy needs are met as building and transportation electrification becomes more prevalent.

We offer many programs and rebates to help with the transition, and we look forward to working with local businesses, including restaurants and manufacturing, to support a successful transition. Visit www.smud.org/rebates to learn more.

As the state and region look forward to safely reopen the economy and many of our public amenities to our families, we encourage everyone to be thoughtful about public interactions and closely monitor local and state health guidelines.

The new June 15th health order has eliminated many previous restrictions such as physical distancing, capacity limits on businesses, and the county tier system. The order still places limited restrictions related to mask use and big public events, as well as settings serving children and youth.

The Sacramento City Council approved a balanced budget that prioritizes the needs of many of our families and residents in this City. The budget highlights increased funding I advocated for to meet the needs of unhoused children and families, an increase of resources for background checks and accountability in the Sacramento Police Department, funding for diversity and outreach in the Fire Department to create employment opportunities for residents, and restoration of the 4th R Program to meet the needs of working parents.

As we move forward toward a post-COVID economy, this budget, combined with the future allocation of \$112 Million in the American Recovery Act funding will help our community get back to work and restore services and programming for youth and families.

## Sacramento County 2021-22 Budget

The Sacramento County Board of Supervisors voted unanimously on June 10 to approve a \$6.5 billion recommended budget for Fiscal Year 2021-22. This year we were able to avoid significant reductions to County programs and we invested in various new areas.

The \$6.5 billion budget consists of \$2.437 billion in Enterprise and Special Revenue Fund expenditures (funded through utility rates, fees and other dedicated revenue), \$3.147 billion in General Fund, and \$947 million in Restricted Funds (funded with federal, State revenue dedicated for a particular purpose).

County staff did an excellent job of engaging with the public to provide opportunities to understand the budget process and allow them to voice their priorities. I look forward to an even more robust community engagement process.

The budget reflects a commitment to equity and inclusion issues, the needs of the homeless in our community, providing an alternative response to people experiencing mental illness, addressing critical needs for capital improvements in the Parks system and at the Mather Community Campus, and improving the condition of County roads. Lastly, I am pleased that I was able to lead the charge to set aside \$500,000 for a youth center in the underserved community of North Highlands.

The Board will soon be discussing the \$300 million received from the federal government through the American Rescue Plan Act. ## **CA Budget Update**

From the Desk of Assemblymember McCarty

Thank you for your continued advocacy on behalf of your neighborhood. I want to take this opportunity to share updates with you.

The Governor's May Revised Proposed Budget is in line with California goals and mostly in line with our Assembly Blueprint Budget-- addressing homelessness/ housing, education, healthcare and providing economic relief for families and small businesses struggling to overcome financial hardships brought by COVID-19.

As Chair of the Assembly Budget Subcommittee on Education Finance and champion for early education, there are many victories in the Governor's plan for children and families. The budget makes investments in our schools to ensure ALL schools reopen in the fall for the 2021-22 school year. In addition, there was \$96B invested in ongoing funds for \$21k in per-pupil funding - the highest watermark ever for K-12 education. The proposed budget also includes Universal Transitional Kindergarten which will provide every 4 year old in the state access to a high quality early education. To further support working and low-income families throughout the year, the budget also includes \$1B for increased availability of before/after school/summer programs. The budget also includes \$3.5B for youth behavioral health grants to ensure our students' mental health needs are addressed. A \$2.2B for College Savings Accounts for low-income 1st graders which will help transform lives and prepare our students for higher learning as well. For college students, investments were made to expand middle-class scholarships, and \$4B for Higher Education student housing and the Debt Free College plan, via Cal Grant expansion and modernization, which will support many more students in being able to graduate college without suffering from tremendous debt.

It is my honor to represent you in the California State Assembly, and I will continue to work in the legislature to deliver on these issues in 2021 and beyond. Please stay connected and visit my webpage at https://a07. asmdc.org for continued updates on legislation.

Organizers for the 28<sup>th</sup> Annual Sacramento SPCA opted to continue with the virtual walk one-more year in place of the traditional walk-in-the Park Doggy Dash. Like last year, residents supported the event by taking their four-legged companion for a walk in their neighborhoods to support the cause. The event raised over \$165,000 for the Sacramento SPCA. # **Neighborhood Parks Reopen!**

Oki and Glenbrook Parks are open for use again. The basketball courts, dog parks, tennis courts, playgrounds, baseball fields, picnic areas, and swimming pool are ready again being enjoyed by the neighborhood. However, while the City parks are re-opening, City Hall remains closed to the public. Zoom remains the standard for all City related meetings.

# Swim at Oki Park Pool

Oki main pool is again open to the public! Admission is \$2 for youth (17 and under) and \$4 for (Adults 18 and older). The main pool areas are currently staffed with lifeguards. However, the wading pool and mushroom area will remain closed until they can be staffed with lifeguards. The Coloma Center at 4623 T Street remains closed to the public due to COVID so the traditional frequent swimmer cards and pool rentals are not currently available.

In order to swim in water greater than chest depth, participants must pass a swim test. The swim test is administered by aquatics staff and a wrist band will be provided to participants who successfully pass it.

A patron must submerge their head under water, surface, and then immediately swim the width of the pool (15 yards) on their front while comfortably maintaining forward movement without touching the bottom or sides of the pool. Patrons are not permitted to stand on stairs or structures in the pool adjacent to the water that is greater than chest depth if they have not passed the swim test.

Non-swimmers (those who have not passed the swim test and the water is greater than chest depth) must remain within an arm's reach of a supervising adult.

Only aquatic department issued lifejackets are permitted. No other forms of flotation are permitted. Anyone in a lifejacket is considered a non-swimmer and must remain within arm's reach of a supervision adult.

# **Stay Safe This Summer**

Summer is here and the Sacramento Police Department would like to share some prevention tips regarding home and auto burglaries.

HOME BURGLARY PREVENTION TIPS

- Get to know your neighbors and what vehicles belong at their house.
- When something doesn't look right, call the police.
- With the summer heat and cool nights, it is easy to leave a window open; remember to lock your doors and windows.
- Put locks on gates that lead to backyards.
- If leaving on vacation, set up mail to be collected or stored at USPS.
- Install outdoor motion lights.
- If possible, install motion activated cameras, like a Ring, Nest, or Arlo to identify people coming onto your property.

AUTO THEFT PREVENTION TIPS

- Never leave your vehicle unattended and running.
- Park in your garage, if available.
- Park in a well-lit and highly visible location.
- Don't leave valuables in your vehicle and if you must, make sure they are not visible.
- Close all windows tightly (summer heat) and lock all doors.
- If you park in a parking garage take your ticket or access key with you. That is the thief's ticket out.
- And remember these three things: HIDE your things; LOCK your car; TAKE your keys.

# **Changes at Sac County Probation**

On April 19, 2021, Chief Probation Officer Lee Seale announced his resignation from the Sacramento County Probation Department. During Seale's eight years with probation, he was at the forefront of probation, promoting positive change by applying innovative methods for assisting clients while increasing safety in the community. Seale was selected by a unanimous vote to serve as the next Executive Officer of the Superior Court of California, County of Sacramento beginning June 2021.

Marlon Yarber was appointed as the Interim Chief Probation Officer in April. Chief Yarber has decades of experience in the probation field and has been an Assistant Chief Probation Officer (ACPO) for Sacramento County for seven years. He had oversight of Adult Operations from 2013 through 2018 then transitioned to Juvenile Operations overseeing the Youth Detention Facility Juvenile Court, Juvenile Field, and Placement.

With Marlon's appointment, ACPO Julie Wherry has been entrusted with oversight of Professional Standards as well as both Adult and Juvenile Operations. # **Busy Year at Fire Station 60**

It has been a busy year for station 60. We responded to 2,641 calls last year. That is an increase of 1.5% compared to 2019. Calls received in this area and responded to by other units when Engine 60 is busy add an additional 1058 calls in our little corner of the City. Overall, your Sacramento Fire Department ran 94,215 calls in 2020 out of 24 fire houses.

Here are just a few items of interest-

Check the batteries in your smoke detector, check the batteries in your CO detector. If your detector begins making noise and you suspect that there is no reason – it could be trying to tell you that it's time for replacement. Check the underside of your detector and it will say what the different beeps mean and sometimes have an expiration date as well. If you have any doubts, call 911.

The Department website is a great resource for information at www.cityofsacramento.org/fire. Most questions can be answered there. For example, the prevention link is a resource if you have questions about code violations.

Last but not least, if you plan on heading out to one of our water sources for some fun, please don't forget your personal flotation device. If you would like to borrow one, please stop by any of these fire stations and we will loan them out to you - 1, 5, 8, 11, 15, and 60.

Suggestions for dealing with the issues to date have varied from no parking to limited vehicle parking for example two/three hours parking (eg. 7:00am to 10pm with no parking 9:00pm to 6:00am. Other more creative suggestions have included bright lights under the bridge and landscaping with large river rocks or two dog parks (one for large dogs and one for small dogs). The Association agrees that it is time to take action.

# Water At Tiscornia Beach In Discovery Park Is Contaminated And Unsafe For Swimming

Water tests have been conducted every Saturday at Tiscornia Beach at the mouth of the American River since July 2020 by three retired university professors. Once out of the rainy season, the tests have consistently found E.coli bacteria levels that exceed U.S. Environmental Protection Agency standards for safe swimming. "E.coli represents risk of disease because it comes from feces which can carry any number of diseases from infected people, including Shigella dysentery and Salmonella," said Robert Metcalf, professor emeritus, Biological Sciences, Sacramento State University. "EPA recommendations for swimming water set 320/100 milliliters (3.2 per one ml-about 1/5 teaspoon) as the maximum acceptable level of contamination. Our tests show that level is regularly exceeded at Tiscornia Beach." "Hundreds of children use this beach and they are most vulnerable to swallowing contaminated water," said Mary Beth Metcalf, MD, retired Clinical Professor of Pediatrics, UC Davis. "The elevated levels of pollution at Tiscornia Beach greatly increase the risk of disease." Alan Wade, professor emeritus, Social Work, Sacramento State University, noted that if tests found E.coli pollution at a coastal beach at the elevated levels detected at Tiscornia Beach, the beach would have been shut down months ago. "Save the American River Association has been urging local officials to close Tiscornia Beach or at least post easily seen and read signs on the beach warning beach users," Wade said. "But those requests have been ignored."
