SMUD Enhances Storm Response Following Unprecedented '23 Storms

I'm sure like me, you all remember this time last year when a series of extreme storms, heavy rains and hurricane-force winds roared through Sacramento, leaving 600,000 customers without power and hundreds of trees and power poles down all around us.

Thankfully, SMUD worked tirelessly to restore power to more than 90% of our customers within 24 hours. Recognizing that severe weather events are unfortunately becoming more frequent, SMUD spent last year carefully evaluating and improving our storm response efforts and we've made some significant changes to our emergency operations and practices.

In short, we've:

- Increased the number of staff to assess storm damage. This helps us provide accurate restoration times more quickly.
- Expanded our contract crew network for more help from outside SMUD, if needed.



- Established new processes, including digitizing some processes out in the field, to provide improved estimated restoration times.
- Implemented new technologies to support safety, streamline processes, and increase collaboration and communication.
- Added new features to our Outage Center at smud.org/Outages, to give customers the ability to look up an outage by address and get
 more granular information about where SMUD is at in the restoration process for their specific outage.

Youth Apprenticeship Programs

The California Youth Apprenticeship Advisory Committee, where I serve as a member, is helping the state launch youth apprenticeship by designing criteria for \$60 million in program funding. The funds will support planning and implementation projects to create youth (ages 16-24) apprenticeship and pre apprenticeships in nontraditional fields (finance, healthcare, etc.). Registered apprenticeship programs for youth between the ages of 16-24 combine academic and college credit based technical classroom instruction with paid work experience through a proven earn-and-learn model. It provides the foundation for youth to choose from several pathways across a wide range of industry sectors and transferable skills to the workforce. Other states like Colorado, Wisconsin, Georgia, and Maryland already offer youth apprenticeships. Employers invest in youth apprentices to grow their long-term employee pipeline and diversify their workforce. Valley vision is hosting a convening of employers and educational agencies on February 6th to create interest in Sacramento seeking state funds to launch youth apprenticeships in childcare, mental health, green jobs, information technology (IT), and education.

Save Water and Money This Spring With Help From the City of Sacramento

Whether it's making the switch to drought-tolerant landscaping or finally replacing that decades-old toilet in your bathroom, there are plenty of changes you can make in and around your home to cut back on how much water you use.

To help with those changes, the City of Sacramento's Department of Utilities has several rebates available to make it more affordable:

- Grass conversions: Get up to \$3,000 for replacing grass in your yard with drought-tolerant landscaping and an extra \$200 to get creative help from a City-approved landscaper. Winter and spring conditions are also ideal for new plants to establish their roots.
- Irrigation upgrades: Receive up to \$400 to make your irrigation system more efficient, such as converting to highefficiency sprinkler nozzles and drip irrigation.
- Smart controllers: Get up to \$400 for certain smart irrigation controllers, which can save the average home up to 15,000 gallons of water each year compared to a standard controller.



- High-efficiency toilets: Receive up to \$125 for replacing toilets manufactured before 1992 with newer models that use less water.
- Washing machine upgrades: Get up to \$125 to replace a traditional washing machine with a new high-efficiency model that uses less water and energy.

The Department of Utilities also has several resources available to help you save water and money, including in-person consultations and free advice from water conservation specialists. For more information, visit SacWaterWise.com.

Working to Address Public Safety

Happy New Year! Thank you for your advocacy on behalf of your neighborhood.

In December, I welcomed my new appointment in the legislature as Chair of the Assembly Public Safety Committee. This committee covers many topics that are top of mind for Californians, including substance abuse and the rise of retail crimes. I look forward to supporting balanced and common sense policies for this upcoming year.

In my new role as chair, the Public Safety committee held its first informational hearing on retail theft in December. During this hearing, we were able to hear about the effects that retail theft is having on our communities and businesses, as well as possible solutions.

Furthermore, I am proud to announce that I have introduced my first bill of the session, AB 1794. This legislation aims to reduce repeat offenses of retail crime and drug offenses, reevaluates public safety accountability measures, and modifies the Safe Neighborhoods and Schools Act, Proposition 47.

We know voters approved Proposition 47 in 2014, but it is now our responsibility to look at and correct any unintended consequences. We need to establish diversion and rehabilitation treatment programs as mandatory during sentencing without reverting to mass incarceration policies of the past. I am eager to put forward a realistic, impactful, and unified solution that focuses on enforcement and empathy. We must keep California businesses open and our neighborhoods safe.

Happy New Year from the Office of Councilmember Guerra. In this next year, we are looking to continue advocating for College Glen. We have been busy meeting with community members and all the various agencies that are involved with encampments in the neighborhood. We are currently working on short term and long-term solutions for these locations, including housing options. The newest shelter is up on Roseville Road and will house an additional 240 community members. The Capitol Park Hotel has also reopened in Downtown as permanent supportive housing with 134 studio apartments fitted with bathrooms and kitchenettes and access to services.

We are also looking forward to another year full of community engagement with the College Glen neighborhood. Will Antinetti, the District 6 Policy and Constituent Affairs Lead, lives in College Glen with his wife. Our office has been meeting with community leaders to determine what our 2024 neighborhood priorities are and have already started drafting proposals and reaching out to City Staff to address these needs. Our office has also been working on activating Oki and Glenbrook Parks, both through community events and advocating for park improvements. We are excited with the work we accomplished in 2023 and cannot wait to continue it in 2024!

College-Glen Real Estate

New Year and potentially a "new" real estate market. 2023 was a very slow year in regard to the amount of home sales both in College-Glen and Sacramento. 8% mortgage interest rates caused there to be not a lot of buyers and not a lot of sellers. Many would be sellers were sitting on their wonderful 3% mortgages and not wanting to sell. Only 74 homes changed hands in market sales in 2023. That is significantly lower than the average of 101 homes sold per year from 2018 – 2022. But because of the low supply of homes for sale, that kept pricing stable. Of the 74 homes sold in 2023, the average sales price was \$526,625. The highest sale for the year was \$700,000.

Looking forward to 2024, interest rates have dropped significantly since the high of 8%. Now in the mid 6% range. That has stimulated a lot of buyers and we are starting to see an increase in buyer activity to start the year. Due to lower interest rates, 2024 should see more buyers, more sellers and more home sales in College-Glen and Sacramento as a whole. How much more remains to be seen... the market will hinge on which direction interest rates go from here.

In 2023, the Sacramento Police Department announced the creation of District 7. The launch of the redistricting went live on January 13, 2024. Our department remains committed to continually identifying ways to improve the service we provide to our community. The creation of District 7 achieves service improvements in many ways. Previously, District 7 was part of District 6, the city's largest district. At times, officers could find themselves on a call at McKinley Park only to be dispatched to Florin Perkins Road and Elder Creek Road on their next call, delaying response times. District 7 splits the old District 6 in half, dedicating officers to each area and improving response times.

District 7 increases opportunities for increased officer visibility while allowing further community engagement opportunities. Our department values partnerships and recognizes that combating crime is a shared responsibility amongst our officers and community members. Our mission remains to collaborate with our community to solve neighborhood problems and enhance the quality of life in our city.

Lastly, District 7 allows our supervisors to manage patrol officers closely while looking for more opportunities to guide and mentor them. Moreover, the district's creation permanently assigns a geographical Lieutenant to address long-term problems. Save the American River Trees By Nancy Kniskern

The US Army Corps of Engineers is planning to bulldoze 500 trees, replace a natural edge of the river with controlled river bank reconstruction involving thousands of boulders, and displace birds, wildlife and fish that inhabit this riparian corridor along the

American River. This river has been deemed a Wild and Scenic river by Congress in 1981 for its "outstandingly remarkable value" to include recreational opportunities, such as fishing, kayaking, hiking, wading, and picnicking. We love our wooded trails and often enjoy watching waterfowl, beaver, muskrat, salmon, deer, coyote rabbits and over 150 species of birds, often from the river's edge.

The Corps is committed to a program to shore up the river banks to prevent erosion. The approach the Corps uses is not unique to Sacramento; rather it has been used on rivers in other states. However, many of us



feel that this river's edge with the clay banks, specific soil elements, and the splendid growth of a variety of trees (including the Heritage Oaks) and other vegetation has nature's own abilities for preventing erosion. Additionally, we worry about the loss of access to the river for the many recreational activities.
